1. The Author hereby assigns to the Publisher, and the Publisher hereby accepts, for the full period of copyright throughout the world and all renewals and extensions thereof the full copyright of the Contribution. This assignment includes, but by no way of limitation, the sole and exclusive right to publish, sell, give access to and license the use of the Contribution in all languages, in whole or in part, including any abridgement and substantial part thereof, in book form, in a database with other works and in any form, including, without limitation, mechanical, electronic and visual reproduction and publication, electronic storage and retrieval systems, including delivery of or giving access to the Contribution by internet, extranet and intranet and all other forms of electronic publication now known or hereinafter invented.

2. The Publisher confirms that the following rights are reserved to the Author:

- a. The right after publication to reproduce the Contribution free of charge, in whole or in part, in a compilation of the Author's own works in print, such as a collection of articles and/or lectures.
- b. The right after publication to quote the Contribution and/or build on the content of the Contribution, on the condition that this does not constitute a reproduction of the whole Contribution.
